How to enter:

1. Shop at Bethlehem Town Centre between 13 June to 25 July 2019.
2. Spend \$40 or more in one transaction (you must retain your receipt).

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this “Shop and Win” Promotion (“Promotion”) is deemed acceptance of these Terms and Conditions.
2. Subject to clause 3, this Promotion is only open to New Zealand residents aged 18 years or over.
3. Three prize promotion. Main prize, \$5,000 shopping spree at Bethlehem Town Centre and two additional prizes that will be drawn fortnightly through the promotional period of \$1,000 and \$2,000.
4. The following are ineligible to enter: (i) employees of The Promoter or any of the tenants or retailers in the Bethlehem Town Centre (as defined in Clause 5 below) or any of The Promoter’s agencies or suppliers that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who The Promoter has previously notified is not permitted to enter The Promoter’s promotions.

To receive an entry in this Promotion, eligible individuals must, undertake the following steps: (a) spend 40 or more in any single day, in one (1) transaction at any participating retail store at Bethlehem Town Centre, during the Promotion Period, and (b) complete all fields on the entry form and drop the entry into the entry box in store at participating Bethlehem Town Centre retailers.

The following receipts are not valid receipts for the purpose of the Promotion: (a) receipts recording deposits into bank accounts, banking services and payment of bills; (b) receipts recording Layby payments except where a Layby is finalised and payment completed during the Promotion Period; (c) ATM or EFTPOS receipts; (e) credit card or bank statements; and (g) receipts that The Promoter has reasonably determined to have been tampered with or have been obtained fraudulently or are a reprint of the original receipts.
8. Entrants must retain their original purchase receipts for all entries as proof of purchase. Failure to produce the proof of purchase for all entries when requested may, in the absolute
